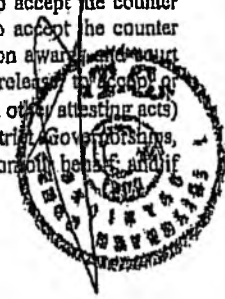

POWER OF ATTORNEY

We/I, the undersigned, hereby duly declare that we have appointed Gönec Gürkaynak with the ID number [redacted], member of the Istanbul Bar and registered with the Beşiktaş Tax Office under the number [redacted] 4 and İlay Yılmaz with the ID number [redacted], member of the Istanbul Bar working with work security at Lokmanbekim Gürkaynak Ortak Avukat Bürosu, to represent us/me jointly or individually as independent lawyers before the Supreme Court of Appeals, Accounting Court, Higher State Council, Regional Administrative Courts, Tax Courts, State Security Courts, criminal and civil courts other judicial bodies of the Turkish Republic which has been or will be established by Laws, public prosecutor's offices, courts bailiff's offices, bankruptcy offices and/or bankruptcy administrations and other governmental offices of the Turkish Republic at their each and every department and level in all conflicts, lawsuits, seizures, attachments, bankruptcies, criminal investigations, which have been or will be brought by or against us, to perform, follow up and finalize all necessary legal transactions, to file complaints and to make explanations; to perform all necessary transactions required to preserve our rights and interests; to employ the powers stated in Article 73 of the Civil Procedure Law and in the meantime to file and participate, lawsuits, execution and bankruptcy proceedings and to follow up and finalize the same before courts, courts bailiff's office, bankruptcy offices, and/or bankruptcy administrations; to apply for criminal investigation and to defend us/me; and if need be to give powers of attorney with all or a part of these powers to others or make others to participate with all or part of these powers, or dismiss them. This power of attorney grants no powers with respect to the requests, including address information given as per Internet protocol standards and other traffic information, which might be evaluated by the company Twitter, Inc. only in case the judicial authorities of the Turkish Republic submit their request to Twitter, Inc. located at the address of 1355 Market Street, Suite 900 San Francisco, California, 94103, U.S.A. within the scope of the "Agreement on Mutual Cooperation in Return of Criminals and Criminal Matters" signed by and between the Turkish Republic and the United States of America and under all its relevant legislation. This power of attorney grants no powers with respect to information that cannot be held by persons who are independent lawyers of the company appointed with power of attorney or other acts that are not possible for them to conduct. No statement in this power of attorney can be interpreted to the opposite of such, against the explicit will of the proxy giver. The lawyers names of whom are stated in this power of attorney have been appointed to represent us/me jointly or individually as independent lawyers to submit, and serve all kinds of petitions and documents with their signature to the relevant offices and institutions and receive the same on our behalf; to employ and hear the witnesses and experts and to accept or refuse the witnesses and experts employed by the counter party; to initiate and/or perform any kind of arbitral proceedings before any kind of arbitral bodies, to nominate an arbitrator/arbitrators, to challenge an arbitrator/arbitrators, to represent us and defend our rights before an arbitrator/arbitrators/arbitral tribunal; to propose, accept and refuse oath; to realize all required transactions before notary publics, to issue and reply to protests and notifications; to impose and cancel attachments, to employ surveys, to be present at the surveys, to object against survey reports, to request re-employment of the survey; to execute and revoke preliminary or final attachments, injunctive relieves or executive measures; to submit oral pleadings, to apply for the determination of evidence; to request transfer of lawsuits; to refuse and file complaints against judges, experts, arbitrators, witnesses and clerks, to attend hearings, to submit or receive documents by hand, to take copies of the same, to review and request the correction of the documents, to represent us before tax offices, tax objection commissions, tax appeal commissions, provincial reconciliation commissions and other bodies that have been or will be established by Law in these respects, to request reconciliation, to sign reconciliation minutes, to receive and prepare all kinds of documents, to amend the lawsuit, to participate in lawsuits as intervener; to appeal against all kinds of decisions of courts, to ask for the revision of judgments and re-trial, to waive the lawsuit, to accept the counter party's waiver of lawsuit, to waive enforcement and appeal of the judgment, to accept the counter party's waiver of appeal; to ask for enforcements and execution of the arbitration awards and court decisions; to apply to be free from attending the trials; to collect; to settle and release; to accept or reject the lawsuit, to represent us while carrying out attesting (apostil attesting and other attesting acts) and approval acts regarding any kind of document before Governorships, District Governorships, Consulates and any other official authority, to perform all necessary transactions on behalf and

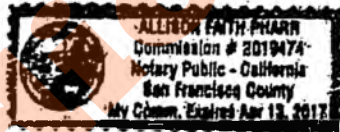


