ADDITIONAL PROTOCOL

TO THE AGREEMENT ON SECURITY COOPERATION BETWEEN THE GOVERNMENT OF THE REPUBLIC OF TURKEY AND THE GOVERNMENT OF THE REPUBLIC OF AZERBALIAN

The Government of the Republic of Turkey and the Government of the Republic of Azerbaijan (hereinafter referred to as "Parties"),

Desiring to make amendments to the Agreement on Security Cooperation between the Government of the Republic of Turkey and the Government of the Republic of Azerbaijan signed in Ankara on 13 November 2013 (hereinafter referred to as "Agreement") in accordance with paragraph 3 of Article 12 of the Agreement,

Have agreed the following:

ARTICLE 1

Subparagraph "c" in the paragraph 1 of the Article 2 of the Agreement has been amended as follows:

"c) human trafficking, smuggling of migrants forced labor and irregular migration;".

The following subparagraphs have been added to come after subparagraph "f" in the paragraph 1 of Article 2 of the Agreement:

- "g) crimes committed on the basis of religious radicalism;
- h) espionage and subversive activities;
- i) forgery and circulation of payment methods and securities;
- j) smuggling of all kinds of goods and other items;
- k) crimes against the life, health, honor and dignity of citizens;
- I) property crimes;
- m) illegal trade of organs, tissues and cells"

ARTICLE 2

Fourth paragraph of Article 2 of the Agreement has been amended as follows:

"4. The Parties may cooperate in the fields of In-Service Trainings, Basic Law Enforcement Trainings, Bachelor's and Graduate Education and Doctoral Programs."

ARTICLE 3

Subparagraph "b" of Article 3 of the Agreement has been amended as follows:

"b) They may agree to carry out joint law enforcement operations in conformity with their national legislations. The implementation procedures shall be agreed upon by the authorities of both Parties as mentioned in article 6 of the Agreement.".

ARTICLE 4

Subparagraph "b" of first paragraph 1 of Article 6 of the Agreement has been amended as follows:

"b) From Azerbaijan side 1. Ministry of Interior;
2. State Security Service."

ARTICLE 5

Paragraph 2 of Article 10 of the Agreement has been amended as follows:

"2. Unless otherwise agreed upon, expenses for the accommodation and meetings shall be covered by host Party whereas international travel expenses shall be covered by the sending Party.".

ARTICLE 6

This Additional Protocol shall enter into force on the date of the receipt of the last written notification by which the Parties notify each other, through diplomatic channels, that their necessary internal procedures have been completed. This Additional Protocol shall constitute an integral part of the Agreement and shall remain in force as long as the Agreement remains in force.

This Additional Protocol signed by the undersigned - duly authorized by their Governments on 25 February 2020 in Baku in two original copies in Turkish, Azerbaijani and English languages, all texts being equally authentic. In case of any divergence of interpretation, the English text shall prevail.
